POSITION: Assistant/Associate Professor of Sport Psychology. This is a nine-month tenure-track position in the Department of Kinesiology, Recreation, and Sport Studies beginning August 1, 2022.

RESPONSIBILITIES: Conduct independent and collaborative research leading to publication in scholarly, refereed journals. Teach graduate and undergraduate courses in applied sport psychology with an emphasis in ethics and multicultural/socio-cultural considerations. Advise/mentor graduate students and supervise doctoral dissertations upon approval. Participate in professional and institutional service. Seek external funding to support research agenda as appropriate.

QUALIFICATIONS: Required - Applicants must have an earned doctorate in Kinesiology or related area, with expertise in sport psychology. Evidence of expertise and scholarly achievement in specific areas of the field of applied sport psychology. Candidates must have an interest in applications of sport psychology concepts and principles for a variety of settings (e.g., sport, industry, rehabilitation, military). The person who holds this position will be expected to have effective interpersonal and communication skills, and a substantive commitment to diversity, equity, and inclusion. Desired – Demonstrated record of teaching excellence and an active research agenda, a record of obtaining or the potential to obtain external funding, and in progress toward or attained certification as Certified Mental Performance Consultant (CMPC). Preference will be given to candidates with expertise in multicultural/sociocultural considerations and competencies as it relates to professional delivery of service or research.

SALARY: Competitive and commensurate with experience.

ACADEMIC AND LIVING ENVIRONMENT: The Sport Psychology and Motor Behavior concentration and specialization is housed in the Department of Kinesiology, Recreation, and Sport Studies. The University of Tennessee, Knoxville is a Carnegie I Research Institution.
